- 6. The policy owner must sign this form in the presence of 2 witnesses.
- 7. If a Trust Nomination has previously been made for the policy, this form must be accompanied by Form C.
- 8. The insurer is not bound by this Trust Nomination for all transactions effected under the policy, including payouts, unless this form has been sent to the insurer by way of notification
- 9. In relation to the personal data collected for this insurance Policy:
